# OUR SWEEPSTAKES

## 1. DOES PUBLISHERS CLEARING HOUSE REALLY AWARD ALL THOSE PRIZES?

Absolutely! Our contests are registered in the states of New York and Florida and surety bonds have been purchased from a major insurance company to guarantee that our prizes are awarded. In addition, a certified public accounting firm audits our sweepstakes.

Real people do win. The winners you've seen in our TV commercials are real people who have won money from us, not actors.

## 2. CAN I ENTER WITHOUT MAKING A PURCHASE AND WIN?

**NO PURCHASE NECESSARY TO WIN** is an ironclad guarantee at Publishers Clearing House. You do not have to buy anything or pay any money to claim your sweepstakes prize. All you have to do is return your entry in a timely fashion - with or without an order. All mail containing sweepstakes entries is processed under strict security to assure timely, accurate entry of all orders and non-orders into the sweepstakes. Many of our winners did not send orders in with their winning entries.

**SKILL GAME CONTESTS:** The special skill game contest are separate from any other sweepstakes. A purchase must be made in order to be eligible for these contests.

## 3. WHEN ARE THE PRIZES AWARDED?

Currently, a Multi-Million Dollar and a One Million Dollar prize are awarded every year. Other prizes are awarded with varying frequency. Specific dates and schedules are published in the Official Rules in our Bulletins.

## 4. HOW ARE THE WINNERS SELECTED?

All of Publishers Clearing House giveaways are conducted under the strict control of independent auditors and giveaway supervisors. Our winner selection methodologies are fair and unbiased. There are two methods we use:

**Matching Winning Number** - A winning SuperPrize number is selected at random. Publishers Clearing House does not know the winning number until giveaway end. Throughout the life of the sweepstakes, Publishers Clearing House assigns SuperPrize numbers to outgoing Bulletins. Any one of the numbers assigned to you while the giveaway is going on could be the winning number.

**Random Drawings** - A two-step process is used for random drawings. Incoming entries are prequalified either manually, by specially trained contest judges using raffle cages, or electronically, by computer. Then, on drawing day, all qualified entries are sequentially numbered and a bingo cage is used to randomly pick the winner.

## 5. HOW DO I KNOW IF I WON A PRIZE?

We missed you! This notification is a contact request for an appointment to be made for prize disbursement. A representative of Publishers Clearing House will contact you in one of two ways: (1) by mail, or (2) in person. You won't have to lift a finger to find out if you've won. Winners are contacted no later than 30 days after the winner selections.

No one else — not even a celebrity — is authorized to notify you of a win in the Publishers Clearing House Sweepstakes. More important, our notifications include no special offerings or unusual conditions to meet before collecting your prize. There is no processing fee or special handling charge.
